Western North Carolina Paddlers Lead River Restoration Efforts After Hurricane Helene

Six months after Hurricane Helene's devastating floods, paddlers in Western North Carolina are leading the efforts to restore the region's waterways. MountainTrue has removed 286,000 pounds of trash and debris from their local rivers and streams—often one raft at a time. In a collaboration effort between paddlers, outfitters, and the U.S. Forest Service, Stackhouse Boat Launch, a key whitewater access point, has been reopened for commercial and public use. But there's still work to do!

Colorado Stream Access Coalition: Advocating for Clear, Legal Rights to Access Colorado's Rivers and Streams for Responsible Outdoor Recreation



Despite Colorado being the most popular destination for river recreation in the country, they have some of the worst public access laws in the west. The Colorado Stream Access Coalition believes that there is a path forward to ensure that outdoor recreation on Colorado's rivers can be enjoyed by all while ensuring that private landowner and water rights are protected.

Under federal law, states own the beds of navigable waterways, holding them in trust for public use, including fishing, floating, and recreation. But Colorado has failed to uphold this trust. In fact, the state has consistently undermined public rights to access navigable waters, even denying their navigable status outright.

For non-navigable waterways, the situation is even more restrictive. A 1979 Colorado Supreme Court ruling declared that the public has no right to use waters flowing over private land for recreational purposes without landowner consent. This decision disregards the Colorado Constitution, which declares that all natural streams are "the property of the public." Justice Carrigan, dissenting in the case, argued passionately that our waterways were dedicated to the use and enjoyment of all people—not just the select few who own land along their banks.

Paddling Action Heats Up at OKC RIVERSPORT for the Second Weekend of U.S. Canoe Slalom & Kayak Cross Team Trials 2025 Pan American Championships Results

After an exhilarating first weekend of racing at the 2025 Canoe Slalom & Kayak Cross Pan American Championships in Montgomery, Alabama, the paddling community now turns its attention to OKC RIVERSPORT, where the second weekend of the U.S. Canoe Slalom & Kayak Cross Team Trials and ICF Ranking Race will take place from March 28-30. From March 21-23, top athletes from Argentina, Brazil, Canada, Chile, Colombia, Mexico, Peru, the United States, and Venezuela competed at Montgomery Whitewater, vying for the title of Pan American Champion. With stunning weather and top-tier performances, the event provided an incredible showcase of paddling talent.

As the competition shifts to Oklahoma City, athletes will continue their battle for a place on the U.S. Canoe Slalom & Kayak Cross Team. The ICF Ranking Race adds an extra layer of intensity, as paddlers vie for international recognition and crucial ranking points.
